ightning season is upon us! Are your communication sites properly bonded to a grounding electrode system and ready? HICAPS Inc. has been a leader in communication site grounding and lightning investigation/mitigation for more than 15 years.

HICAPS' team of auditors works with public safety agencies during design, construction, post-construction and site maintenance phases to ensure grounding systems are properly installed and maintained.

Improper bonding and damage to grounding electrode systems can lead to costly equipment replacements, and can pose a danger to site personnel. It only takes one flaw in the overall grounding electrode system to create a point of entry causing a disaster at a communication site.

Have you updated any of the site utilities lately? If so there is potential for improper grounding as utility companies do not follow the same grounding standards. Has your site experienced extreme weather? If so there is potential for compromised grounding. Do you know how long it takes for a lightning strike at a communications site to dissipate? Even if you do, would you trust reaching out to unlocking that gate or touching that metal shelter doorknob, if that site had not been



audited within the previous year?

HICAPS' subject matter expert, Tom Smithey, has been busy educating the industry by presenting at the 2016 APCO conference and acting as a trusted advisor to our partners. Tom and his team have completed well over 1,000 audits nationwide and have ventured as far as South Africa to help our customers stay grounded. The team continues to expand the program beyond new and modified audits.

Our pre-construction and construction phased audit program has seen tremendous growth in 2016 and 2017. The auditors review the electrical drawings in the initial phase to confirm that proper grounding standards were considered before drawings are accepted. The auditors then follow the construction schedule working closely with the general contractor and electric team to develop a phased approach to ensure that each level of completion complies with the required grounding specification. Leaving nothing to chance, this ensures nothing has been overlooked. We have helped our clients avoid costly mistakes and saved them countless dollars with this proactive approach.

The annual maintenance audit program is another area that is experiencing continued growth. HICAPS has a variety of county- and city-wide programs that cater to the needs of the customer. A typical program consists of an annual standard audit followed by a report that categorizes the areas that need critical attention, moderate attention and items that may need attention in the future. The auditor then works with the client on a plan of action which includes managing the repairs or modifications discovered during the audit. This program provides our clients with a more efficient way to prioritize and budget for necessary maintenance and repairs.

HICAPS continues to manage multiple site compliance contracts that keep our customers grounded.
